The meeting was called to order at 7:30 p.m. by Bryan Cummings, with Richard Wilson and Ray Campbell in attendance. Guests present were Bob Bryan, Dee Williams, Ken Harris, Audrene Burns, and Caleb Duda. The pledge to the flag was given.

Public Comment

Caleb Duda presented a request to have Medevac Ambulance Service placed on a rotating schedule through Lawrence County 911. A resolution would need passed in order to make this change. Ms. Black will contact the Lawrence and Mercer County Public Safety Directors to discuss the pos and cons of the matter and the topic will be revisited at the July meeting.

Dee Williams questioned how it would work for residents who hold a membership with Noga Ambulance if Noga Ambulance was no longer the primary ambulance service for Wilmington Township.
