Sewer Project Engineering Update:

- Joshua Kalp and Kristen Johnson gave an update on the surveying of properties for the sewer project and that letters were sent to the residents notifying them of their upcoming presence on their property. First floor elevations will be collected during these visits.
- A Pennvest meeting is scheduled for September 12 to discuss funding.
- Individual Sewage Planning Modules will need reviewed to identify whether residents with a SFSTF will be required to connect to the sewer.
- The township will need to reach out to residents whose homes are beyond the state 150 feet requirement for connection and see who is interested in connecting. Regardless of interest, DEP may still require their connection. This is unsure.
- An LSA grant will be applied for to help fund the sewer project.

Mr. Bolinger gave an update on a 2011 CAT skid steer he had found and would like to purchase for the amount of \$18,000
